

**INSTRUCTIONS FOR 14TH JUDICIAL CIRCUIT APPROVED  
MOTION TO COMPEL FINANCIAL DISCLOSURE**

1. This form may be used when a case involves financial issues such as alimony, child support, attorney's fees, and/or equitable distribution of marital property and debts.
2. **Both parties are required to file a Family Law Financial Affidavit.** This requirement cannot be waived by the parties.
3. Both parties shall file a Certificate of Compliance with Mandatory Disclosure and produce the financial documents listed on the certificate. *Fla.Fam.L.R.P. 12.285(d) and (i)* [Form 12.932]. Full disclosure is required unless modified by order of the court or agreement of the parties. *Fla.Fam.L.R.P. 12.285(a)(1)*.
4. This form may also be used to compel answers to interrogatories if you have filed a Notice of Service of Standard Family Law Interrogatories [Form 12.930(a)], and the other party has not responded.
5. If the opposing party fails to provide this disclosure, this motion may be used to force compliance.
6. Before filing this motion, **you must make efforts to obtain the information.** Keep a record of your requests and be ready to provide documented proof of your requests at a hearing. This will be important for purposes of possibly holding the other party in contempt.
7. **If your case involves Child Support Enforcement (Department of Revenue),** please be sure to check the applicable box on Page 1 of this form and send a copy to both the opposing party and to the Department of Revenue.
