**RE: CIRCUIT ARTICLE V INDIGENT SERVICES COMMITTEE
FOR THE FOURTEENTH JUDICIAL CIRCUIT, EFFECTIVE JULY 1, 2004**

Whereas, section 27.42, Florida Statutes, was created in Chapter 2003-402, Laws of Florida and amended in Senate Bill 2962, passed by the 2004 Florida Legislature, and established the Circuit Article V Indigent Services Committee, its composition, and its responsibilities;

Whereas, section 27.42, Florida Statutes, created in Chapter 2003-402, Laws of Florida and amended in Senate Bill 2962, passed by the 2004 Florida Legislature, identifies the chief judge or chief judge's designee to serve as chair of the Circuit Article V Indigent Services Committee;

Whereas, section 27.42, Florida Statutes, created in Chapter 2003-402, Laws of Florida and amended in Senate Bill 2962, passed by the 2004 Florida Legislature, identifies the Public Defender, or his or her designee as a member;

Whereas, section 27.42, Florida Statutes, created in Chapter 2003-402, Laws of Florida and amended in Senate Bill 2962, passed by the 2004 Florida Legislature, states that the chief judges shall appoint two additional members to the committee – one experienced private criminal defense attorney and one experienced civil trial attorney. Both attorneys shall serve a two-year term and shall be prohibited from serving as court-appointed counsel; and

Whereas, section 27.42, Florida Statutes, created in Chapter 2003-402, Laws of Florida and amended in Senate Bill 2962, passed by the 2004 Florida Legislature, outlines the basic responsibilities of the Circuit Article V Indigent Services Committee to manage the appointment and compensation of court-appointed counsel within the circuit; to maintain a registry following any eligibility and performance standards set by the Legislature; to develop a schedule of

standard fees and expense allowances for categories of cases specified in s. 27.5303, Florida Statutes; and to meet at least quarterly.

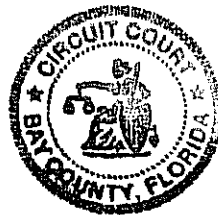
Now Therefore, it is **ORDERED and ADJUDGED** that the following individuals are appointed as members of the Fourteenth Judicial Circuit Article V Indigent Services Committee effective July 1, 2004:

- ▶ The Honorable Don T. Sirmons, Circuit Judge, is appointed as the Chief Judge's designee and is to serve as Chair,
- ▶ The Honorable Herman Laramore, Public Defender, Fourteenth Judicial Circuit;
- ▶ Mr. Waylon Graham, private criminal defense attorney, to serve a two-year term until June 30, 2006, and is prohibited from serving as a court-appointed counsel during his term; and
- ▶ Mr. Ross McCloy, private civil trial attorney, to serve a two-year term until June 30, 2006, and is prohibited from serving as a court-appointed counsel during his term.
