ADMINISTRATIVE ORDER #2004-00-12

RE: INSTRUCTIONS FOR USE OF AFFIDAVIT OF INDIGENT STATUS FORM, EFFECTIVE JULY 1, 2004

Whereas, section 27.52, Florida Statutes, as amended by Chapter 2003-402, Laws of Florida and further amended by Senate Bill 2962, passed by the 2004 Florida Legislature, provides that the clerk of circuit court shall use a form developed by the Supreme Court to determine indigent status for purposes of appointing a public defender or a private attorney or any other due process services;

Whereas, section 27.52, Florida Statutes, as amended by Chapter 2003-402, Laws of Florida and further amended by Senate Bill 2962, passed by the 2004 Florida Legislature, also requires the clerk of court to assist a person who appears before the clerk and who request assistance in completing an affidavit of indigent status form;

Whereas, in order to implement the aforementioned legislation, the Supreme Court of Florida, in Case No: SC04-994, dated June 17, 2004, approved and authorized the publication of an affidavit of indigent status form for use by the Clerks of Circuit Courts (see Attachment A);

Whereas, Rule 10-2.1(a), Rules Regulating the Florida Bar, requires any non-lawyer who assists an individual in the completion of legal forms to provide the person with a copy of a disclosure, and the Supreme Court of Florida, in their corrected Opinion SC04-994 instructed the Clerks of Circuit Court to include language required by Rule 10.2.1(a) in any disclosure form; and

Whereas, the Supreme Court of Florida, in corrected Opinion SC0-994, authorized the Chief Judge of the circuit to prepare instructions for the use of the approved affidavit of indigent status form and has required that said instructions be filed with the clerk of circuit in the respective county of the circuit and with the Clerk of the Supreme Court of Florida.

Now Therefore, it is ORDERED AND ADJUDGED that the following instructions shall be followed for use of the approved affidavit of indigent status form:

- 1. The Affidavit of Indigent Status form (Attachment A) approved by the Supreme Court of Florida shall be completed by any individual who seeks a determination of indigent status for purposes of appointing a public defender or a private attorney or any other due process services.
- 2. Any individual may request assistance from the Clerk of Circuit Court, or his/her designee, in completing the Affidavit of Indigent Status form.
- 3. In any instances wherein the Clerk of Circuit Court, or his/her designee, who is a non-lawyer, assists any individual in the completion of the Affidavit of Indigent Status form, the Clerk of Circuit Court, or his/her designee, shall provide a disclosure form, in substantially the same format as contained in Attachment B, to the individual requesting such assistance prior to completion of the Affidavit of Indigent Status form. The Clerk of Circuit Court or his/her designee, and the individual seeking assistance to complete the Affidavit of Indigent Status form shall place their signature on the disclosure form. The individual seeking assistance shall be provided a copy of the executed disclosure form. The original executed disclosure form shall be maintained by the Clerk of Circuit Court.
