**ADMINISTRATIVE ORDER #2004-04-02**

**RE: HOLMES COUNTY CANVASSING BOARD – REVISED**

**Whereas**, section 102.141 (1), Florida Statutes, provides for a county canvassing board which shall be composed of the supervisor of elections; a county court judge, who shall act as chair; and the chair of the board of county commissioners;

**Whereas**, section 102.141 (1)(a), Florida Statutes, states that if no county judge is able to serve or if all are disqualified, the chief judge of the judicial circuit in which the county is located shall appoint as a substitute member a qualified elector of the county who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed. In such event, the members of the county canvassing board shall meet and elect a chair; and

**Whereas**, County Judge Robert E. Brown will be unable to serve on the Holmes County Canvassing Board due to health reasons and has requested the Chief Judge to appoint a substitute member to the Canvassing Board for the primary elections scheduled for August 31, 2004.

**Now Therefore, it is ORDERED AND ADJUDGED** that the following qualified elector, **Mr. Sidney Johnson**, who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed, shall replace the Holmes County Judge, The Honorable Robert E. Brown, as a member of the Holmes County Canvassing Board for the primary election scheduled for August 31, 2004.




ORDER OF RECUSAL
