ADMINISTRATIVE ORDER # 2005-00-07

**RE: CIRCUIT AND COUNTY JUDGE DESIGNATION OF AUTHORITY
FOR NEW BAY COUNTY JUDGE,
EFFECTIVE NOVEMBER 2, 2005 THROUGH DECEMBER 31, 2005**

Whereas, Rule 2.050 (b) (2), Florida Rules of Judicial Administration, establishes that the chief judge of a circuit "shall exercise administrative supervision over all courts within the judicial circuit;"

Whereas, Rule 2.050 (b) (3), Florida Rules of Judicial Administration, directs the chief judge to develop an administrative plan for the efficient and proper administration of all courts within the circuit;

Whereas, Rule 2.050 (b) (4), Florida Rules of Judicial Administration, allows the chief judge to assign judges to courts and divisions and determine length of each assignment. It also allows the chief judge to assign any judge to temporary service for which the judge is qualified in any court in the same circuit; and

Whereas, Bay County was allocated a new county judge during the 2005 legislative session in which the appointment of Michael J. Hauversburk was made by the Honorable JEB Bush, Governor of the State of Florida;

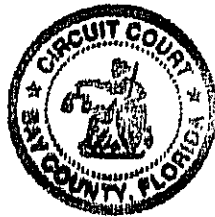
Now Therefore, it is ORDERED and ADJUDGED that pursuant to the aforementioned authorities vested in the Chief Judge of the Fourteenth Judicial Circuit, I do hereby assign and designate the Honorable Michael J. Hauversburk to proceed to the county courts in all counties within the circuit, to hear, conduct and dispose of all matters which shall be presented to him as temporary judges of said county courts. Judge Hauversburk is hereby vested with the powers and

prerogatives conferred by the State Constitution and the Laws of Florida as Judge of the Court to which he is hereby assigned.

Likewise, I further assign and designate Judge Michael J. Hauversburk to proceed to the circuit court, to hear, conduct and dispose of all matters which shall be presented to him as temporary judge of said circuit court. Judge Hauversburk is hereby vested with the powers and prerogatives conferred by the State Constitution and the Laws of Florida as Judge of the Court to which he is hereby assigned.

This assignment shall be effective, nunc pro tunc, November 2, 2005, and continue in force through December 31, 2005. **DONE and ORDERED** in Chambers in Marianna, Florida, Jackson County, Florida, this 10 day of November, 2005.
