ADMINISTRATIVE ORDER #2009-00-01

RE: BAY COUNTY JUDGES TIMOTHY C. CAMPBELL AND JOE GRAMMER,  
DESIGNATION OF AUTHORITY, EFFECTIVE JANUARY 6, 2009

Whereas, Rule 2.215 (b)(2), Florida Rules of Judicial Administration, establishes that the chief judge of a circuit "shall exercise administrative supervision over all courts within the judicial circuit;"

Whereas, Rule 2.215 (b) (3), Florida Rules of Judicial Administration, directs the chief judge to develop an administrative plan for the efficient and proper administration of all courts within the circuit;

Whereas, Rule 2.151 (b) (4), Florida Rules of Judicial Administration, allows the chief judge to assign judges to courts and divisions and determine length of each assignment. It also allows the chief judge to assign any judge to temporary service for which the judge is qualified in any court in the same circuit;

Now, Therefore, it is **ORDERED** and **ADJUDGED** that pursuant to the aforementioned authorities vested in the Chief Judge of the Fourteenth Judicial Circuit, I do hereby assign and designate the Honorable Timothy C. Campbell and the Honorable Joe Grammer to proceed to the circuit court, to hear, conduct and dispose of all matters which shall be presented to him as temporary judges of said circuit court.


Said judges are hereby vested with the powers and prerogatives conferred by the State Constitution and the Laws of Florida as Judge of the Court to which he is hereby assigned.

Moreover, I assign and designate the Honorable Timothy C. Campbell and the Honorable Joe Grammer representing the county of Bay, to proceed to the county courts in all counties within the circuit, to hear, conduct and dispose of all matters which shall be presented to him as temporary judges of said county courts within this circuit.

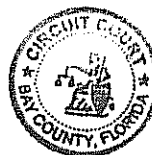
Said judges are hereby vested with the powers and prerogatives conferred by the State Constitution and the Laws of Florida as Judge of the Court to which he is hereby assigned.

This assignment shall become effective January 6, 2009, and continue in force for six (6) months through June 30, 2009.
