ADMINISTRATIVE ORDER # 2017-00-01

(Rescinding Administrative Order #2015-00-06, 2016-00-04, and 2016-00-05)

RE: CIRCUIT JUDGE ASSIGNMENT PLAN BEGINNING APRIL 1, 2017, AND SHALL REMAIN IN EFFECT UNTIL FURTHER ORDER

Whereas, Rule 2.215(b)(2), Florida Rules of Judicial Administration, establishes that the chief judge of a circuit "shall exercise administrative supervision over all courts within the judicial circuit."

Whereas, Rule 2.215(b)(4), Florida Rules of Judicial Administration, allows the chief judge to assign judges to courts and divisions and determine length of each assignment. It also allows the chief judge to assign any judge to temporary service for which the judge is qualified in any court in the same circuit; and

Whereas, Rule 2.215(b)(3), Florida Rules of Judicial Administration, directs the chief judge to develop an administrative plan for the efficient and proper administration of all courts within the circuit.

Now, Therefore, IT IS ORDERED and ADJUDGED that the circuit court judicial assignments as reflected on Attachment #1, pages 1 and 2, are incorporated herein and shall be in effect from April 1, 2017 until rescinded or amended by further order of the court.
