ADMINISTRATIVE ORDER # 2023-00-01

**RE: APPOINTMENT OF MAGISTRATE ERIN E. BAUR TO THE
FOURTEENTH JUDICIAL CIRCUIT**

WHEREAS, Rule 1.490, Florida Rules of Civil Procedure; Rule 5.697, Florida Probate Rules; Rule 8.257(a), Florida Rules of Juvenile Procedure; Rule 8.625(h), Florida Rules of Juvenile Procedure; Rule 12.490, Florida Family Law Rules of Procedure allow the judges of the Fourteenth Judicial Circuit to appoint Magistrates from among members of The Florida Bar; and

WHEREAS, Rule 12.491, Florida Family Law Rules of Procedure allows the Chief Judge to appoint child support enforcement hearing officers from among members of The Florida Bar; and

WHEREAS, to continue the efficient disposition of civil, family law, dependency, probate, guardianship, Baker Act, and Marchman Act cases in Bay, Calhoun, Gulf, Holmes, Jackson, and Washington Counties, it is necessary to appoint magistrates and child support enforcement hearing officers.

NOW THEREFORE, it is ORDERED and ADJUDGED that **Erin E. Baur** is hereby appointed Magistrate for the Fourteenth Judicial Circuit, in and for Bay, Calhoun, Gulf, Holmes, Jackson, and Washington Counties, Florida; as provided by the aforementioned rules of court and sections 394.467, 397.681, and 744.369(2), Florida Statutes, and any other statutory or rule provision authorizing the appointment of a general master. **Erin E. Baur** is also hereby appointed Child Support Enforcement Hearing Officer pursuant to 12.491, Florida Family Law Rules of Procedure for the Fourteenth Judicial Circuit, in and for Bay, Calhoun, Gulf, Holmes, Jackson, and Washington Counties, Florida.

The Magistrate shall:

- A. Take the oath of office required of officers by the Constitution of the State of Florida, and the oath shall be properly recorded in the Official

Records of the Clerk of the Circuit Court for Bay County, Florida, with this administrative order.

- B. Perform duties in accordance with Rule 1.490, Florida Rules of Civil Procedure; Rule 5.697, Florida Probate Rules; Rule 8.257(a), Florida Rules of Juvenile Procedure; Rule 8.625(h), Florida Rules of Juvenile Procedure; Rule 12.490, Florida Family Law Rules of Procedure; and sections 394.467, 397.681, and 744.369(2), Florida Statutes, and any other statutory or rule provision authorizing the appointment of a magistrate, applicable rules of court, the Code of Judicial Conduct, and as provided herein.
- C. Be a member in good standing of The Florida Bar.
- D. Serve at the pleasure of the Chief Judge and a majority of the circuit judges in the circuit.
- E. Serve without requirement of bond.

Additionally, Rule 12.491, Florida Family Law Rules of Procedure continues to be invoked and child support enforcement hearing officers shall continue to be in use in the Fourteenth Judicial Circuit.

Each Child Support Enforcement Hearing Officer shall:

- A. Perform duties in accordance with Rule 12.491, Florida Family Law Rules of Procedure, other applicable rules of court, the Code of Judicial Conduct, statutes, and as provided herein.
- B. Consider Title IV-D and non Title IV-D proceedings.
- C. Be a member in good standing of The Florida Bar.
- D. Serve at the pleasure of the Chief Judge and a majority of the circuit judges in the circuit.

Each Magistrate and Child Support Enforcement Hearing Officer shall take testimony and establish a record by electronic means pursuant to Rule 2.535, Rules of General Practice and Judicial Administration. The record will be made, retained, and destroyed in accordance with Rule 2.430, Rules of General Practice and Judicial Administration; Rule 2.535, Rules of General Practice Judicial Administration; and Rule 12.491(h), Florida Family Law Rules of Procedure, and administrative orders governing court reporting in this circuit.

All actions taken before this date by previously appointed magistrates and child support enforcement hearing officers are hereby confirmed.
